**~ DATO' DR PETER MOONEY TROPHY ~**

• 27 September 2003 •

This year the Pupil's Welfare Committee of the Kuala Lumpur Bar, organised the inaugural Oratory Competition. This competition was held on 27.9.2003 at the Bar Council Auditorium. A total number of 14 participants were selected for the competition to win the coveted Dato' Dr. Peter Mooney trophy. The winner also takes the prize money of RM3, 000.00.

Dato' Dr. Peter Mooney was born in Ireland and graduated with a Masters in Arts from the University of Glasgow in 1948 and obtained his LL.B. from the University of Glasgow in 1951. He was admitted to the Faculty of Advocates, Edinburgh and called to the Scottish Bar in 1952.

Dato' Dr, Peter Mooney was the Secretary of State for the Colonies and Crown Counsel of Sarawak in 1953 and was the Acting Attorney General and Public Prosecutor of Sarawak from 1956 to 1960.

He was admitted to the Malaysian and Singapore Bar in 1961 and became a partner of Skrine & Co. from 1963 to 1988. During his illustrious career as an advocate and solicitor, Dato' Dr. Peter Mooney had appeared before the Privy Council on several occasions.

From 1978 until 1997 Dato' Dr. Peter Mooney was elected to the Bar Council of Malaysia, a record 19 years of service in the Malaysian Bar. During this period Dato' Dr. Peter Mooney had served as the Vice-President of the Bar Council for 3 terms in 1986/87, 1987/88 and 1989.

Currently, Dato' Dr. Peter Mooney is a Consultant of Skrine, the Director of Assunta Hospital, Petaling Jaya and Tun Tan Cheng Lock College of Nursing, Kuala Lumpur. He is also a Director of Fatimah Hospital in Ipoh and the Chairman of Hospis, Malaysia.

The Kuala Lumpur Bar Committee thanks Dato' Dr. Peter Mooney for his contributions to the Malaysian Bar and is honoured to name the inaugural oratory competition trophy after him.
