Our final and perhaps most moving visit was to the Taman Megah Handicapped and Disabled Home on 29 February 2004. The home has more than 80 children who suffer from down syndrome, autism, cerebral palsy, etc, some as young as a year old.



All of these homes rely primarily on donations from the public to sustain themselves. We were extremely encouraged by the overwhelming support that we received from our members and sincerely hope that we shall continue to receive such support in our efforts to assist the less fortunate.

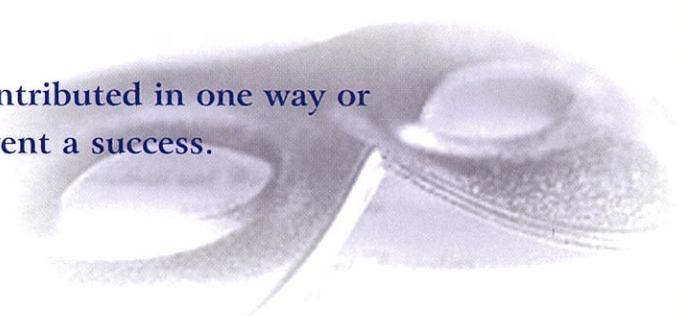
